## ● Putting the Pieces Together . . .

One of the most efficient ways to accomplish an undertaking as extensive as the Portage Lake Watershed Forever Plan is through master plans, ordinances and ordinance administration and enforcement. As luck would have it, Onkama Township and the Village of Onkama are working to complete such a Joint Community Master Plan.

Concerns identified by year-round and seasonal residents (water quality, community character and natural resources) are key factors being weighed by the Leadership Team working to develop the plan. You can learn much more about it at an informal **Open House** on Tuesday, November 25, from 5 p.m. to 8 p.m. at the Farr Center.

## ● Portage Lake Stewardship Homeowners' Packets

Nearly 1,000 packets of information were compiled by dozens

of volunteers and hand-delivered in mid-July to households in the Portage Lake watershed. Materials included watershed 'basics'; tips on maintaining watershed-friendly lawns; the proper use and upkeep of septic systems; threats posed by phosphorus and invasive species, and more. ● **You talkin' to me?** - A large banner was raised on M-22 to focus attention on how our actions impact the watershed: "**What we put in the watershed, stays in the watershed. Think about it.**"

● **Signs of the times** - The Manistee County Road Commission installed permanent signs on seven county roads (Milarch, 8 Mile, 9 Mile, Lakeshore, Miller and 11 Mile Roads) to let people know they were entering the watershed.

● **Invasion!** In late September, the Portage Lake Association, the Portage Lake Garden Club and Jr. Clio hosted a Phragmites Demonstration Project.

Over 100 people attended.

They heard all about this aggressive, invasive non-native plant and learned that a survey of the lake would be conducted to



determine how much was present. After further consideration, however, a decision was made to survey the entire lake for *all* invasive species. Results indicate that 75% of Portage Lake

shows evidence of Phragmites *and* there are significant amounts of Eurasian water milfoil also present.

The PLWF Executive Committee took immediate action and appointed a work group to help develop a 5-year comprehensive strategy to control and manage this problem. (*The complete report and additional information is available at [portagelakewatershed.net](http://portagelakewatershed.net).*)



● **Water Testing** - The PLWF Monitoring and Inventory Committee and the Village of Onkama took weekly water samples for E. coli testing at the Village Beach. During July and August, seven other places on the lake were tested three times for E. coli.

**Oxygen Levels Normal** - The Little River Band of Ottawa Indians tested for dissolved oxygen levels in two deep holes in the lake and one shallow location. The samples indicate that oxygen stratification levels in the lake were normal.



**OHS Testing** - For the 13th straight year, Onekama High School students conducted semi-annual water tests as part of their earth science classes. The information they've gathered comprises the longest data set available about Portage Lake.
