Fall 2014 President's Letter

It is that time of year when the nights get cooler, the winds blow harder and the days get shorter. Our summer guests have mostly left the area and the snowbirds are making plans for their winter journeys. Apples, pumpkins, gourds and squashes are being harvested and you will find them at roadside stands in the area. The trees are starting to show color and it promises to be a spectacular autumn color display. The Scarecrows of Onekama are starting to populate Main Street.

The summer of 2014 was a good one for Onekama. Two new businesses opened and several added services. The community supported our local businesses with all of them reporting increased traffic and sales. The Portage Point Inn staff continued to formulate their master plan to make the Inn a destination location. In 2014, the PPI had cottage and condo rentals, limited marina service (docks), and they hosted some local catered events on their premises. Numerous site maintenance and improvement projects are underway.

The PLA enjoyed community support for our petunia program, annual fundraiser, Monday Night Concerts in the Park, 2nd annual Craft Beer Tasting & 3rd Annual Pig Out for Scholarships. The PLA has joined the Onekama Lions and other community groups to revitalize Onekama Days, bringing the latter two attractions to that event.

While summer is our busy season, we still have events and activities for the remainder of the year:

Petunia rollup Sept. 24, Fall Festival on Oct 11th and Christmas in Onekama on Nov 22nd which includes: Celebration of Lights, Onekama Originals tree auction, Chili Cookoff, and Arts, Crafts & Baked goods sale. PLA is also the source of funding for the Village's Holiday Lights display on Main Street. Quite a few PLA members will start their volunteer work at the Onekama Consolidated School this fall.

Plans are also being discussed for the return of Winterfest, which will be in mid-February if we get enough interest. The Concert Committee has almost completed their search for the 2015 lineup, and the fund raising committee is starting to plan for the June 27th, 2015 Fundraiser event.

We increased our efforts at community and regional promotion through our 1-Onekama, Michigan and Portage Lake Association Face Book pages and have received many compliments on our efforts. BUSY SPRING AND SUMMER FOR PARKS AND RECREATION COMMITTEE

An Arbor Day Celebration was held on April 25 at the North Point Park Shelter. Featured speaker was Katie Grzesiak, Invasive Species Specialist, Northwest Michigan Invasive Species Network, Grand Traverse Conservation District. Tom Gerhardt gave a presentation on the history of parks in Onekama Village and Onekama Township. There was a Portage Lake Watershed Forever presentation, free trees, park tours and refreshments.

The Parks Appreciation Days was held once again at North Point Park during Onekama Days (August 2). A large turnout enjoyed refreshments supplied by Jim Mrozinski and his Onekama Marina crew, plus ice cream treats were offered at the Pierhead Light. Pickle Ball and Wiffle Ball were introduced this year during Onekama Days. Both drew a positive response and plans are to continue to further encourage participation and enjoyment of these activities.

The township board gave approval for installation of an irrigation well at North Point Park, not to exceed \$9,000.

The group is awaiting news on the results of a re-application of the grant for Langland Park. The grants are generally announced in early December. Fire rings were donated to Langland Park by Wendell and Shirley Brooks. A big thank you to the Brooks!

The Pierhead Light is installed and will make its official "debut" on July 5, 2015 at 10 p.m. with the dedication ceremony and the lighting of the Pierhead light. A commemorative plaque will be installed on an existing stone at the site, describing the history of the light. Numerous donations have been received for the light, plaque and electrical work.

The committee would like to place the unused docks from Community Dock across the wetland area in Glen Springs Park.

The Parks & Recreation Committee will work on future projects during the winter months in order to be ready to implement them in the Spring. The group meets on the third Thursday of the month at 8 a.m. in the Township Hall. It welcomes any and all those who have a desire to keep the parks at their very best potential. Come join us!

Ballot Language

I. BONDING PROPOSAL

Shall Onekama Consolidated Schools, borrow the sum of not to exceed One Million Six Hundred Ninety Thousand Dollars (\$1,690,000) and issue its general obligation unlimited tax bonds therefor, for the purpose of remodeling, equipping and re-equipping the school building, in part for security purposes; and purchasing school buses?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2015 is .35 mill (\$0.35 on each \$1,000 of taxable valuation). The maximum number of years the bonds may be outstanding, exclusive of any refunding, is fifteen (15) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is .54 mill (\$0.54 on each \$1,000 of taxable valuation).

The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$1,560,000. The total amount of qualified loans currently outstanding is \$0.00. The estimated computed millage rate may change based on changes in certain circumstances.

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

II. BONDING PROPOSAL

Shall Onekama Consolidated Schools, borrow the sum of not to exceed Six Hundred Ten Thousand Dollars (\$610,000) and issue its general obligation unlimited tax bonds therefor, for the purpose of remodeling, equipping and re-equipping the school building; and acquiring, installing and equipping the school building for instructional technology?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2015 is .27 mill (\$0.27 on each \$1,000 of taxable valuation). The maximum number of years the bonds may be outstanding, exclusive of any refunding, is seven (7) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is .42 mill (\$0.42 on each \$1,000 of taxable valuation).

The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$1,560,000. The total amount of qualified loans currently outstanding is \$0.00. The estimated computed millage rate may change based on changes in certain circumstances.

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

Fall News from The Village of Onekama

Are you ready for Fall? It seems as though summer came and went within 4 weeks! Fall is here- so it is time to remember that school is back in session and that means more traffic on the streets around our school. Remember- **STOP signs are not a suggestion!** Please come to a **full stop and look both ways** before entering the intersection. **Cyclists- stop signs apply to you as well!**



Even though the weather was not summer like -it was a busy time for the village. **Mill Street was resurfaced** and problems with the storm water system in that area were addressed as well.

The Village Park **beach**, a project that has been in process for more than two years, finally got a new look after weather related delays and was ready for your enjoyment in August. The major goal of the Explore the Shores project was to make access to Michigan's waters available for everyone...able bodied as well as those with mobility problems. This project increases access to Portage Lake from the park via the Peron stairs and mobility mats for **all** individuals. Thanks to all who contributed to this project including: Oleson Foundation, Alliance for Economic Success, Portage Lake Association, Portage Lake Watershed Forever, Onekama Township, as well as the contractor and village officials.

Following a public hearing, revisions to the Village **Zoning Ordinances**, a major project over the past two plus years, was approved by the Village Council in August.

Initially the process started with an ad hoc committee forwarding their suggestions and ideas to the Planning Commission for consideration. Those suggestions (along with other items the commission found required updating, some due to changes in the State Statute, or new items to be included) were forwarded to the Village Council for their approval. Onekama has a **large watershed** which includes land away from the lake and it is very important to our community. A short definition of a watershed is: land area where ground water from runoff enters the lake via creeks and streams. Runoff includes sediment and pollutants from septic systems, lawn management, and rain washing off pavement, driveways and gutters. Basically any water or other liquid that seeps into the ground will find its way to the lake.

This summer the Watershed Forever held 6 information sessions addressing "**Keeping Portage Lake and its Watershed Healthy**". These covered: safe yard/lawn care; invasive species and fishing; how do we keep the lake from dying; water works- where does Portage Lake water come from?; What about Wetlands?; and ...not a drop to drink (is your drinking water safe?). We hope there will be new informational sessions next year as we all need to know how to keep our lake safe and healthy because it impacts our health too!

Recycling appropriately is essential!! The recycling containers at the Township Hall are heavily used especially during the summer months. There is also a trailer for recycling cardboard and paper that the school band uses to raise funds for their program. These items are NOT recycling appropriate: Styrofoam, furniture, broken windows, foam rubber, TVs or electronics, farm equipment, etc. **Please read the signs on the containers and only recycle what is listed. Let's recycle responsibly!**

Onekama Township Hall has a new look at the front entrance.

Landscaping, trees, plants and a new informational sign are in place, completed with the assistance of memorial donations for the project. The parking lot was also resealed recently.

The township board has hired Clinton Osborn for the Captain's position in the Fire and Rescue Department. Unless out on call, he is in the fire department from 7 a.m. to 3 p.m. five days a week.

The Portage Point Inn is undergoing changes under the new ownership of Bob Gezon. Current plans include digging two wells and replacing the roof on the hotel. Infrastructure issues need to be resolved, and according to the owner, he would like to sell, lease or partner the Inn with someone to run it.

Trash Day was held June 21 and was successful.

The Revenue Sharing board gave the Fire Department a \$3,945 grant to update the JAWS truck. The department has submitted grant requests for two chain saws and two float dock strainers.

Bob's Roofing of Manistee has completed installation of a new roof on the fire department building and the township hall.

Road work is planned for Lake Isle, Seymour Road, Lake Park Drive, Lakeside Avenue, Clark Road, Ardmore, Arborvitae, Ferndale, Juniper Way, Beachward, Norwood, Ridge Avenue, Happy Hollow, Pine Run Drive and Park Place.



Onekama School Giving Tree

Onekama Schools designed a program eleven years ago called the Giving Tree. The Tree provides families in the Onekama School district with gifts and items they need during the holiday season and assists student families in grades K-12. The program collects items in the months of November and December.

The school, with the help of staff members, creates a list of families in need. From that list, tags are created for each family member with the items needed on the tag. For example, a six year old girl needs a pair of small snow pants so a tag is created with the child's age, gender, and size. A volunteer comes in and takes a tag from the Giving Tree, checks in with the office, and then purchases the item listed. The volunteer then wraps the item and turns it back into the office with the tag. The office makes sure that the gifts get to the families. This program is one big game of Secret Santa Claus.



The school has been able to help a total of 50 families in eleven years with help from the Congregational Church, Lions Club, House of Flavors, school staff and the Portage Lake Association, as well as local residents. Also a big thanks needs to go to Mrs. Milarch for letting me interview and gather this information. Mrs. Milarch is in charge of the program and organizes the Giving Tree. The school thanks those who participate and for your generosity during this season.

How can **you** get a tag? The Student Services Office in the school will set up a Christmas tree and hang the tags in November. If you take a tag, the school would like you to bring the gift wrapped to the office with the tag attached, so the school can put a name on it and get it to the family. The school also understands that it's a busy time of year and not everyone has the opportunity to go out and purchase a gift. Technology Time

Onekama Schools is taking on a new adventure for the 2014-15 school year - the school invested in MacBook Airs for the middle and high schoolers and the elementary students received iPads. Onekama's faculty are very grateful for this opportunity, and they are working on making lessons more technologically based.

Elementary students use their iPads in almost every class. While talking to the 4th grade students during their science class, the students said that they use their text books to learn the lesson, but when they need extra help they use their iPads. An example they gave is to use the online dictionary to find the meaning of words that they didn't know. During my interview the students were using their iPads to watch a video on how bees pollinate other plants by flying flower to flower. Students overall liked having their iPads as another option for learning.

The students are responsible for the welfare of their iPads and responsible for bringing them to class. While the students are learning how to care for their iPads, they aren't able to take them home. After the first three weeks, their parents will watch a presentation on how their kids are responsible for their technology. The iPads were provided with a protective case and it is mandatory to use it. The iPads are not in use all the time in class; the students are still required to learn the lesson, pay attention, and participate in class.

In an interview with 5th grade teacher, Mrs. Brown, she talked about the students that come through her class and how they used their technology. She enjoys the fact that the students have so much information at their fingertips. She also can give the kids who finish early some additional educational work. Mrs. Brown hopes to be able to start a program (when the students are able to take their iPads home) that allows the students to learn the next day's lesson the night before so they have class time to do extra studying on the topic.

Onekama middle and high school students have received the MacBook Air. Since these students are ready for more technology based work, they can say goodbye to text books! All of their books are ebooks which they access online and download files from Moodle. The older students will have their parent meeting mid-Sept. so the students will be able to take their computers home. The students will be able to access their files even without Internet at home, because they will save the documents to their computers while at school. Each will be responsible for their own computer and making sure it's re-charged nightly

The students are excited about this great learning tool. It not only lets them have all they can learn at their fingertips but also it helps with their learning computer technology. The world is becoming more and more technologically based; the jobs and career options we have are more about technology then they've ever been before.

Onekama is very grateful for this opportunity to teach and better our school from a technological standpoint. We are happy to have this opportunity!

Invasive Species Committee Report



The control of eurasian watermilfoil (ewm) continues to be our biggest challenge. We project that we are in a maintenance state and will need to continue to treat approximately the same amount each year that we have treated for the last 3 years. New methods of treatment and products are carefully evaluated each year with our lake manager to maintain best practices. This year 127 acres were treated and the lake was surveyed several times to determine the success of these treatments. Even though the ewm was slow to start this summer, we found new areas of growth in late August and the final treatment for the year was completed on September 8th.

Our phragmites are under control and will only require spot treatments and monitoring again this year. This will be done between September 12 and the middle of October (before the first frost). The crew from Wildlife and Wetlands will again walk the entire shoreline of the lake and spot treat.

We are also concerned about the amount of Japanese knotweed and purple loosestrife that is now growing along our shoreline. We will be treating these as we treat the phragmites. If the 2014 fall treatment of purple loosestrife is unsuccessful, we will consider using beetles to treat next year. We are seeing a large increase in Japanese knotweed throughout Manistee County. This can be even more difficult to eradicate than phragmites. It has a beautiful white flower in the late summer (which some find decorative as we used to find phragmites).

For the last 6 years we have been working with the Onekama Township and the community to educate, survey and treat both aquatic and terrestrial invasives while preserving the water quality, native plants and fisheries of Portage Lake. Information about the activities and work of the Invasive Species Committee and Lake Manager can be found in the annual Lake Management Reports and the monthly reports to the Township Board. These reports are posted on the *watershed link* on the Onekama.info website. Surveys and maps are also available at the township office. With the new 5 year special assessment that was approved in May 2014, we are able to continue our ongoing treatment program and water monitoring of our lake until 2019.

I Hit a Deer!! Now What??

Unless you or someone nearby is injured, DO NOT call 911.

Instead keep this number in your vehicle-

231-723-6241



This is central dispatch at the Sheriff's office- they will talk you through the process.

The number is answered 24/7 and they will notify whatever law enforcement personnel is nearest the scene of your incident.

If you have only stunned the deer and it has run off, you still call dispatch if you have damage to your vehicle and plan to file a claim with your insurance company for repairs.

If the deer is dead, you can request a 'car kill' permit to take the deer for processing. If you come upon a fresh kill, you may also call the same number to acquire a 'car kill' permit.

The Road Commission used to be the agency to call for removal of dead animals in our roads or front yards. However, due to budget cuts, they are now just left for 'nature to take care of them'.
