**ZONING**: Mike Szokola reported that 5 land use permits were issued and his office handled numerous calls regarding zoning issues. He also reported that our contact with them (Manistee County) is up for renewal around October 24, 2020 and he presented a new contract for their services which has different levels for the Village to select and sign. Much discussion followed and President Franz told the board to be ready at the November meeting to vote on this issue. It was also reported that Manistee County has hired a code enforcement officer, Larry Gibson who will handle the violations. More discussion, then Trustee Schwing moved and Trustee Arthur supported to form a committee to discuss the zoning contract and other zoning issues and report back to the council with recommendations. Roll Call: Hudson/no, Burger/no, Miller/yes, Anthur/yes, Schwing/yes and Franz/no. Motion fails. Treasurer inquired about the complaint that was filed in Oct of 2019 RE: canvas shelter/carport. She was told a final resolution is forth coming and apologized for them dropping the ball in responding to this complaint.

## **PLANNING COMMISSION**

-received recommendations for changes to the fence ordinance from the Planning Commission. Lots of questions but no representative was in attendance to answer. This issue will be addressed under unfinished business at the November meeting.
